

Unifi Fun Run 2026 – TERMS AND CONDITIONS

Organised by Unifi Zambia

1. Event Governance

The Unifi Fun Run 2026 is organised by Unifi Zambia in accordance with the regulations of the Zambia Athletics Association (ZA).

All participants agree to abide by these rules as a condition of entry.

2. Registration & Entry

- Registration must be completed through official platforms (online or in person).
- Entry is confirmed only upon receipt of full payment.
- Participants must present valid ID, SMS and/or email at race pack collection (DPO does not qualify).
- Bib numbers are issued individually and may not be transferred, altered, or exchanged.
- Providing false information may result in disqualification.

3. Eligibility

Minimum age:

18 years

Participants under 18 require signed parental/legal guardian consent.

We reserve the right to ask for Doctors letters should the need arise.

Athletes competing for rankings or prizes must meet ZA eligibility requirements.

WINNING RUNNERS and PRIZE ELIGIBILITY

Only THREE ELITE runners per country (male and female categories separately) will be eligible for prize money.

For clarity: if three male ELITE runners from "Country A" qualify, they will be eligible to receive prize money (subject to meeting all event requirements). Any fourth, fifth, or subsequent ELITE runner from "Country A" will not be eligible for prize money.

This rule applies to both races.

The limitation applies to all participating countries except the host country - Zambia, which is exempt from this restriction.

4. Health, Fitness & Assumption of Risk

By entering the Unifi Fun Run 2026, I acknowledge and agree that:

- Marathon running is a physically demanding endurance event.
- Participation involves inherent risks including but not limited to serious injury, illness, dehydration, heat stress, collision, permanent disability, and death.

- I am medically fit, sufficiently trained, and physically capable of participating.
- I have sought medical advice where necessary and take full responsibility for my physical condition.
- I understand that medical services will be available; however, I accept that response times and outcomes cannot be guaranteed.
- I acknowledge that weather conditions, traffic exposure and road surface conditions form part of the inherent risks of a road marathon event.
- I voluntarily assume all risks associated with participation.
- The organisers reserve the right to withdraw any participant deemed medically unfit.

5. Release of Liability & Indemnity

To the fullest extent permitted by the laws of Zambia:

- I hereby release, discharge and hold harmless:
- Unifi Zambia as event organiser
- Solwezi City Mall as venue host
- Zambia Athletics Association
- Event sponsors, partners and exhibitors
- Contractors, service providers and suppliers
- Medical personnel and emergency responders
- Volunteers, marshals and officials
- Landowners, local authorities and public agencies

from any liability for injury, loss, damage or death arising out of or connected with my participation, except where such liability results from proven gross negligence or wilful misconduct.

I agree not to bring any claim against the above parties for matters arising from ordinary risks inherent in endurance events.

6. Emergency Medical Consent

I consent to receiving emergency medical treatment, including CPR, AED use, hospital transfer and necessary medical intervention.

I authorise organisers to share relevant medical information with emergency responders and my nominated emergency contact where necessary.

7. Course, Timing & Race Conduct

The race course is measured in accordance with ZA guidelines. Organisers reserve the right to amend the course for safety or operational reasons.

Organisers' decisions regarding results and placements are final.

8. Anti-Doping

The event is subject to anti-doping rules. Refusal to submit to testing will result in disqualification.

9. Safety & Participant Responsibility

Participants must:

- Follow instructions of officials and medical staff.
- Wear race bib visibly at all times.
- Compete without unauthorised assistance.
- Failure to comply may result in disqualification.

10. Event Changes or Cancellation

- Unifi Zambia reserves the right to modify or cancel the event for safety, operational or force majeure reasons.
- Entry fees are non-refundable in the event of cancellation due to force majeure.

Participation of Differently-Abled Athletes

The Unifi Fun Run supports inclusive participation and welcomes differently-abled athletes.

Participants entering a differently-abled category acknowledge and agree that:

- They are medically fit to participate in the chosen category.
- They take full responsibility for the suitability and safety of their equipment (including racing wheelchairs, hand cycles, prosthetics, or adaptive devices).
- Any assistance required must be declared in advance and approved by the organisers.
- Approved guides or assistants must be officially registered and comply with event rules.
- Participation remains subject to the same inherent risks as all endurance events.
- The organisers reserve the right to require reasonable medical confirmation of fitness where necessary for safety.
- Note that only the 6km is open for this category.

11. Event Photography & Media Notice

Official photographers and videographers will be present.

By participating or attending, you acknowledge that:

- Photography and filming are integral to the event.
- Your image may appear in event materials including website, social media and promotional content.
- If you have questions regarding media usage, please refer to our Privacy Policy.

12. Privacy Notice

By submitting this entry:

- I acknowledge that my personal data will be collected and processed for registration, safety, communication and event administration.
- Data processing complies with the Zambia Data Protection Act.
- My information will be handled securely and shared only where required for event administration, safety or legal compliance.
- Full details are available in the Privacy Policy.

13. Governing Law

These Terms are governed by the laws of Zambia.

14. Acceptance

By registering, I confirm that:

- I have read and understood these Terms.
- I voluntarily accept all risks.
- I agree to be bound by ZA and Unifi rules.
- I accept the Release of Liability and Indemnity provisions.
